Even though I attempt to focus on positive events for our members in this space, I deviate from that custom to report what I consider to be a direct attack upon the interests and efforts for success of the **Mountain Laurel Chamber of Commerce (MLCC)** by the current sitting members of the Mount Pleasant School Board which voted unanimously to rescind its previous action, reported last month in the space, to preserve and expand the grades hosted in the Donegal Elementary School. In May, there was a successful effort to preserve the Donegal Elementary School from closure by the Mount Pleasant School Board this coming year. More than 70 persons, including this writer, attended that session of the Mount Pleasant School Board and asserted vigorously the need for the operation of the school to encourage families to move into and remain within Donegal Township as the resident population is critical to support and preserve those local businesses now members and to become the future members of the **MLCC**. The effort sparked not only success in preservation of the school but also a vote by a majority of the Board members present to return additional elementary grades previously removed by the Donegal Elementary School that had resulted in long bus rides intolerable for young children and overcrowding of other district elementary schools

The members of that Board, at the May 26th meeting, rescinded, by a unanimous vote, the earlier adopted motion to return to community based elementary schools and expansion of the Donegal Elementary School during the 2022-2023 school year. The action will limit the students at Donegal Elementary School to only those children attending grades K through 4, without promise of the continuation of the school or regard for the announced needs of the members of the **MLCC** for local delivery of education to preserve our local businesses. Thereafter, members of the board were observed in the Donegal Area looking at the developed planned communities supporting the tax base of the school district previously disregarded in the decision making of the school board.

In the spirit of the **MLCC** being **BETTER TOGETHER**, I urge each member, reader and those other persons close to members of **Mountain Laurel Chamber of Commerce** to oppose this assault by the Mount Pleasant School Board upon the **MLCC**. Vote in November for **Allison Brooks, Eric Poole, and Brad Coppola**. These candidates openly support maintenance of the existence and expansion of locally delivered education in grades hosted in the Donegal Elementary School being a significant need of the member businesses of the **MLCC**. On this issue, we all will be **BETTER TOGETHER**.

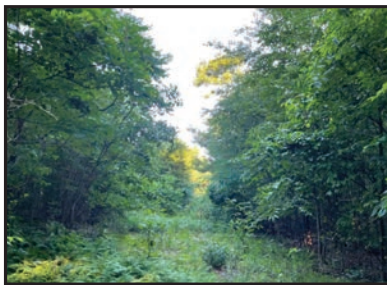

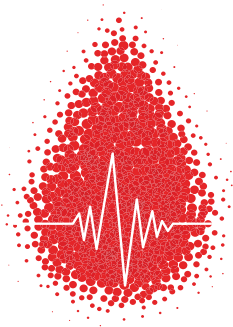
Honorable Mike Reese Memorial Highway

Q

I've been advised to set up a Limited Liability Company for my new construction business. I will be the only owner. What is the process to set this up?

A

You should contact your attorney to help you draft and file a Certificate of Organization and a Docketing Statement, providing the particulars of your new business, including the name, registered office address, organizing members, etc. These documents will be signed and sent to the Corporation Bureau with a filing fee. Once these documents are filed, you will need to apply for an Employer Identification Number (EIN) from the IRS for the business, which is similar to a social security number for an individual. You will also need to contact an attorney to draft an Operating Agreement which is the document that sets forth the rules of operation and the rights of the members of the LLC. After the LLC is registered, you should open a bank account in the name of the LLC. The bank will need to see the filed Certificate of Organization, the EIN for the company, and the Operating Agreement in order to open the bank account.
