





I created a new limited liability company in Pennsylvania for a new business I'm starting. Is there anything that I will need to file for it each year?

Yes, you will need to file annual reports for the LLC with the Pennsylvania Department of State. In November of 2022, the reporting requirements for business entities registered in Pennsylvania was amended, which now requires most business entities registered in Pennsylvania, including corporations, LLCs, partnerships, and others, to file an annual report for the entity. This annual report filing requirement starts in 2025 and a failure to file the annual report can cause the entity to be dissolved, terminated, or cancelled and loss of the exclusivity of the business name. The deadline to file the report each year is dependent upon the type of entity you have. For example, the filing deadline for LLCs will be September 30th of each year.


