**Q** I heard that there is a new reporting requirement for small businesses that is going into effect in 2024. Is that true?

**A** Yes, you are correct. Congress passed legislation in 2021, which requires most small business entities, including corporations, limited liability companies, and others, to report "Beneficial Ownership Information (BOI)" to the Financial Crimes Enforcement Network of the U.S. Treasury Department. This report will identify each person who has ownership or control over the entity. The reporting requirement began on January 1, 2024, so any entity created in 2024 will have 90 days after the entity is created to file the BOI report. For any entity created after January 1, 2025, the 90-day reporting deadline will be reduced to 30 days following the creation of the entity. If you have an entity which existed prior to 2024, you will be required to file the report by January 1, 2025. Therefore, you should call an attorney as soon as possible to inquire about filing the BOI report for your existing business or ask your attorney if this reporting requirement will apply to a business you are creating.

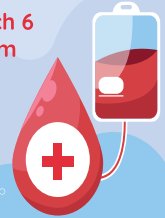
